In those instances, your details are processed in accordance with the conditions stipulated in the law of 11 December 1998 regarding the protection of privacy in the processing of personal details.

Personal details that can be processed

- Your first and last name

- Your IP-address

Third parties

VVOB vzw only passes on your personal details to third parties if this is required for the effectuation of an agreement with you, or to comply with legal obligations.

Mapping your website visits

VVOB's websites store general visitor data, including the IP-address of your computer, the time of visit, and data sent by your browser. These details are used for the analysis of user behaviour on the website (visits and clicks). VVOB vzw uses this information to improve the efficiency of the website. These details are anonymised as much as possible and are not passed on to third parties.

Google Analytics

VVOB vzw uses Google Analytics to track how visitors use the website and how effective the Adwords adverts of
